Settlement funds shouldn't be going for scholarships

Nancy L. York's Feb. 13 letter, "Smoking cessation programs have value," points to the success of tobacco prevention and cessation programs and argues against their elimination. So far, so good. But her proposal to raise yet another tax is off the mark.

Nevada was, in fact, awarded tens of millions of dollars in 1999 for the purpose of treating low-income sick smokers and implementing anti-smoking programs. Instead of using that money for its intended purpose, then-Gov. Kenny Guinn took the lion's share to create a new "Millennium Scholarship" for Nevada college students, awarding up to \$10,000 to those with modest grades and without the benefit of means.

Thanks to inevitable grade inflation in high schools, many of these "scholars" now need remedial help when they enter college. Some are even smokers.

In his 1999 State of the State address, Guinn promised that taxpayer money would not fund this new program. Now, more than a decade later, taxpayer money does indeed help fund the scholarship, while anti-smoking programs are being slashed, and UMC (where indigent sick smokers are treated) is crumbling.

Shouldn't the original tobacco settlement money be used for prevention and treatment as intended, rather than being spent on the ill-conceived and poorly managed Millennium Scholarship program? Ellen Shaw, Henderson

LETTERS: The horrors of cuts

To the editor:

Included among the governor's budget recommendations is the elimination of funding for Nevada's tobacco prevention and cessation programs. Our legislators must be made aware of the devastating consequences if this occurs.

The youth smoking rate has dropped by 48 percent and the adult rate by 30 percent since the creation of these programs, and Nevada is no longer considered the "smokiest" state in the nation. Once tobacco prevention funding is eliminated or significantly reduced, smoking rates quickly rise, resulting in a dramatic reversal of positive trends. These cuts will lead to increased smoking rates and increased medical costs associated with the diseases that result from tobacco use.

The annual health care costs in Nevada directly caused by smoking are \$565 million a year. Additionally, the elimination of tobacco prevention funding would result in tremendous job loss within Nevada.

An alternative to these cuts would be an increase in the state tobacco tax. An increase of \$1 per pack would raise \$78.8 million in new annual revenue to help close the state's budget shortfall, while saving lives. This tax could prevent 18,700 children from smoking, spur 14,000 current smokers to quit, save 9,600 residents from premature, smoking-caused death and save \$460.3 million in health care costs.

In April 2008, 60-year-old Cheryl Rose got a bad cough that wouldn't go away.

Her doctors thought she had asthma — a bizarre turn for a woman who had never had difficulty breathing, not even during frequent workouts at the gym.

A few weeks later, an X-ray revealed that her right lung was filling with fluid at a frightening rate. Doctors told Rose, a woman who lived a healthy lifestyle and had never taken regular medications, that she probably wouldn't live to see 2009.

Rose was diagnosed with Stage 4 lung cancer in June 2008. She had never smoked, and there was no history of cancer in her family. Doctors told Rose what she had suspected: Her cancer likely resulted from years of inhaling smoke at work — in casinos.

And now that she's dying, Rose is on a mission to reform the industry where she spent the best years of her life. She wants smoking banned in casinos.

"God gives each of us a purpose in life," she says. "I'm someone who can't stand by and not do what I can to help. People are afraid for their jobs and they're afraid to take risks. I want to be an advocate for people who are afraid to speak up for themselves."

Working in casinos

Like others before her, Rose saw a career, and good money, in a casino job. She was good with numbers and had taken college-level accounting classes, so a job handling money made sense.

"This was the industry to be in — that's where the opportunities were."

Rose worked in Las Vegas casinos for 22 years, first as a slot attendant, or "change girl," who paid jackpots and made change for customers in the days when slot machines accepted coins. She worked her way up the corporate ladder for more than a decade, finally becoming a slot director, overseeing slot attendants and technicians and working with slot vendors to purchase machines and place them in strategic locations.

She wasn't around smoke much outside of work, as neither friends nor family smoked. But it was ever-present on the job. As a casino manager, Rose accepted that fact — even embraced it.

Allowing customers to smoke wasn't just a way of life in Nevada, with its "live and let live" culture. Enabling smoking, she says, was a profit-driven goal.

Although most gamblers don't smoke, there's plenty of anecdotal evidence — much of it from casino companies — that many repeat gamblers smoke. Several studies have uncovered a strong link between chain smoking and problem gambling. The behaviors reinforce each other.

Rose knew smoking seemed to be good for business, even if it wasn't good for customers.

She says some loyal customers stopped coming, because of doctors' orders to avoid smoke.

But to her, smoke was a small downside to an otherwise fulfilling job.

"This was a good company to work for," she says. "They offered me opportunities I never thought were possible."

Her employer didn't let her lack of a college degree prevent her ascent into management. The company paid for her to attend business leadership courses and UNLV classes in statistics and casino management. A high salary and performance-based bonuses were a testament to her skill as a manager.

All of which goes to explain why she wouldn't consent to be interviewed for this story unless the company's name was withheld. The company shouldn't be singled out, she says.

Rose's conflicted feelings toward her employer are typical of many casino workers who develop health problems linked to smoky environments or the high-stress nature of casino work.

Like many of her peers, Rose isn't suing her employer for health-related damages, nor did she file a workers' compensation claim.

It would be hypocritical, she said, because she had supported her employer's efforts to accommodate smokers. She had encouraged gamblers to light up.

Instead, she is approaching her fight against smoke the same way she is tackling her battle against cancer: by focusing on what can be done in the future rather than what should have been done in the past.

Secondhand smoke

Slot directors have one of the most important jobs in the casino business. Although table games give casinos their mystique, slots make most of the money — and for Rose, overseeing the operation created 60- to 70-hour workweeks.

Rose didn't always hole up in an office. She was a hands-on manager at a company that encouraged interaction between upper management, line workers and customers. She spent a lot of time walking the casino floor and talking to gamblers.

And, in hindsight, breathing in clouds of smoke.

She was aware of the risks of smoking, of course, but "when you're working in the casino industry you're not focused on health issues. You're focused on the bottom line," she explains.

Besides, she adds, "When you're healthy, and you eat right and exercise, you don't think bad things will happen to you."

What she didn't realize, until after her diagnosis, was that she didn't have to be a smoker to develop lung cancer.

Speaking out

Rose was laid off from her job in February 2008 — one of the thousands of Las Vegas casino workers who have lost jobs because of the recession. As a widow, she had no way to stave off foreclosure, so she lost her house, too.

She was left with not much more than that troublesome cough — and her determination to speak out about the danger of secondhand smoke.

A few months ago, she appeared in a public service announcement sponsored by anti-smoking advocates Smoke-Free Gaming and posted on YouTube, calling for a smoking ban in casinos. She joined a group of casino workers participating in a Smoke-Free Gaming rally at the Global Gaming Expo, the industry's largest trade show, in Las Vegas in November.

Mostly, though, Rose is preoccupied with staying alive.

Every three weeks a doctor hooks her up to an IV for chemo treatment. Once a week her doctor draws blood to make sure her blood cell counts are within normal ranges.

Now 61, Rose has so far beaten the odds, living well beyond the typical life expectancy for someone with terminal cancer.

But the cancer cells, which had previously lodged in her spine and hip, recently spread to her liver.

The danger of secondhand smoke is no longer an issue in most workplaces thanks to state and local smoking bans.

But Nevada has protected its casinos from smoking bans — the reason why chronic obstructive pulmonary disease kills at a higher rate in this state than others, according to the American Lung Association.

Don't look for that to change anytime soon.

Because many gamblers smoke, the gaming industry says smoking is good for Nevada's economy.

The courts have shrugged, saying lawmakers haven't banned it.

The state Legislature doesn't want to clear casino floors of smokers because it doesn't want to incur the industry's wrath or risk the loss of gaming revenue.

And even casino workers who are ill from smoke aren't complaining; they say their livelihoods depend on the revenue of gamblers who smoke.

This isn't to say that nothing is being done to minimize the effects of smoking in casinos.

Some of Las Vegas' newest megaresorts have spent millions of dollars on high-tech air-filtration systems that suck up smoke and pump in fresh, scented air. These casinos are noticeably less smoky than some older ones with cheaper systems.

Still, job applicants at Las Vegas casinos are notified that if they work on the gaming floor, they would be working in smoke-filled environments, regardless of whether they are at a luxury resort or a low-end joint.

And when they find the smoke is making them sick, the top concern of a majority of workers is keeping their job, so they don't rock the boat. They figure it wouldn't do them any good anyway.

The Legislature, state courts and employers are lined up against casino floor workers, despite secondhand smoke being classified by the Environmental Protection Agency as a cancer-causing substance responsible for thousands of lung cancer deaths among nonsmoking Americans each year.

That classification — reiterated in a federal study last year that found toxins linked to secondhand smoke in Las Vegas casino dealers — is one of the many reasons Wynn Las Vegas dealer Kanie Kastroll is pushing forward with the first class-action lawsuit aimed at secondhand smoke to hold its ground against Nevada casinos in nearly a decade.

The odds are stacked against her in Nevada, but not as much as they would have been in the past, experts say.

Howard Cole, an employment attorney in Las Vegas who has been a consultant to casinos on secondhand smoke liability, says "it's a changing ballgame right now" because of more smoking bans across the nation — including a partial one pushed through by Nevada voters in 2006 — and a few settlements in favor of casino employees in other states.

"Secondhand smoke is a legitimate concern. And this is still a developing area of law," he says.

Kastroll's Chicago lawyer Jay Edelson says the long-standing code of silence among casino employees is starting to break.

"I've been getting calls from people across Las Vegas and Atlantic City. These suits are not going to go away ... There will be others after them willing to go the distance against these powerful forces."

Stephanie Steinberg, who operates a nationwide support network for casino workers called Smoke-Free Gaming, isn't so sure.

Steinberg says she has been contacted by nonsmoking Las Vegas casino workers diagnosed with lung cancer after decades of breathing smoke at work.

"I ask them, 'Why do you continue to work there if you have lung cancer?' And the answer is always the same. They say

"People who complain about smoke are written up and could lose their jobs," Steinberg says.

Kastroll, 42, is thought to be the first casino worker in Nevada to sue over secondhand smoke while still employed.

"I have everything to lose by doing this, but I'm the kind of person who will speak up if something is wrong," says Kastroll, a dealer for more than 20 years. "Why is secondhand smoke in a casino restaurant, theater or shop viewed as toxic, but in a gaming area it is acceptable — even encouraged?"

She says her suit was spurred, in part, by another dealer who developed cancer. A study last year by the National Institute for Occupational Safety and Health on health risks of secondhand smoke in casinos also contributed to her decision.

The study "validated what we already knew" and served as a "wake-up call" for casino workers, she said.

Dealers who asked to be moved to nonsmoking tables were told no by Wynn Las Vegas, Kastroll alleges in her lawsuit.

Steinberg has been unsuccessful in her attempts to help Las Vegas dealers work at tables where gamblers can't smoke — even a dealer who was seven months pregnant.

"The pit boss told me he doesn't give people 'special treatment,'" Steinberg says.

Kastroll has the clout of holding the presidency of Transport Workers Union Local 721, which represents dealers and is negotiating a contract with Wynn Las Vegas. But Joe Carbon, the union's national gaming director, has publicly distanced himself from her lawsuit, saying the Wynn's air-filtration system is "as good or better than any other property on the Strip." He has also said that lawsuits like this don't help contract negotiations.

Moreover, some dealers want smoking allowed because they think a ban would reduce the number of gamblers and therefore reduce tips, Carbon says.

Kastroll says health and a longer life are more important than money, and her lawsuit says federal and state laws that obligate all employers to provide a safe workplace back that up.

Kastroll is not after money. Instead she is asking the federal court to order improvements in air quality for Wynn's casino workers. If she succeeds, her case would set a precedent and have implications for all casinos.

In its court filings, Wynn notes that Nevada "specifically endorses Wynn's alleged policies and practices toward secondhand smoke" and that smoking is permitted in casinos under the partial smoking ban.

The American Heart Association has pointed out that Nevada's failure to include gambling areas, where smoke is most concentrated, in its smoking ban is the reason the state has not seen a significant decrease in heart attacks. Other states saw such a drop after passing comprehensive smoking bans.

Proponents of Nevada's ban didn't even try to include casinos because they feared the gaming industry would then crush the initiative. A partial victory was considered better than the complete defeats of the past, including efforts to seek workers' compensation for illnesses they claim they suffered as a result of inhaling smoke at work.

Health problems stemming from secondhand smoke — unlike those caused by asbestos, anthrax or other harmful substances — are not covered by Nevada's workers' compensation, the only outlet for workers injured on the job.

Nevada's District and Supreme courts have ruled that workplace smoke claims "must fail" until the Legislature changes state law to specifically cover them. The power to protect casino employees harmed by smoke rests with the Legislature, they said, and not the courts.

Assemblyman Richard Segerblom, an employment attorney, says a smoking ban in casinos is "inevitable" but won't come from state officials or lawmakers. "The Legislature is not going to tackle this because (casinos) are too big a revenue source for the state," he says.

He predicts the ban will come from a ballot initiative driven by the majority of Nevadans who don't smoke or from the <u>U.S. Occupational Safety and Health Administration</u>, which regulates workplace safety and indoor air quality.

That agency tried to pass a bill in 1994 banning workplace smoke. Government workers blamed its failure on President Bill Clinton's need to curry favor with tobacco-growing states in advance of his re-election campaign.

"Under federal law, even workers who want to work around smoke don't have the right to work in a dangerous environment," Segerblom says. "But the administrative process takes time."

While successfully beating back liability claims in Nevada, casinos in other states face an increasingly uncertain legal battlefield over secondhand smoke.

A significant victory for casino employees was a workers' compensation case in 2008 when an Atlantic City resort was found liable for secondhand smoke in connection with a dealer's lung cancer.

Employees also have had some success suing riverboat casinos, but that is in part because federal law enables workers on seafaring vessels to sue employers for damages stemming from workplace injuries.

Casinos aren't entirely off the hook for secondhand smoke: Employers who fail to offer good ventilation systems or rely on pre-ban policies risk higher health care costs and potential legal expenses, according to Cole, the Las Vegas employment attorney. However, because the largest casinos have self-funded insurance programs, they could pass on those higher health care costs to employees in the form of higher health insurance premiums.

MGM Mirage spokesman Alan Feldman says his company — and the industry as a whole — are doing their best to juggle the needs of two vocal interest groups: smokers and nonsmokers.

"I think the industry is trying to do what's right amid conflicting policy directives," he says. "We're in a customer service business, and this is an activity that many customers enjoy very much. We all strive to be good and responsible employers ... but this is also an economic issue."

Kastroll sees it differently.

"We all need our jobs," she says. "But what price can you put on someone's health? On someone's life?"

'Pigeon guy' not flying coop

Police, businessman resolve differences

North Las Vegas finally might have resolved its pesky pigeon (guy) problem.

The city last month reached a compromise in its long-running feud with Nephi Oliva, better known as "the pigeon guy," over what officials said was an illegal pigeon sanctuary he was operating in an industrial area near Cheyenne Avenue and Commerce Street.

"We're doing everything we can to accommodate a businessman who is a bit outside the norm," Tim Bedwell, a North Las Vegas police spokesman, said Tuesday.

The agreement requires Oliva, 36, to apply for a special use permit to keep operating Nevada Pigeon Control, at 2920 Brookspark Drive. The permit would not, however, allow him to store hundreds of pigeons in a 6-foot-high, 65-footlong aviary he built in the parking lot.

The city will allow Oliva to keep only a handful of pigeons for "operational use" as lures to help trap other birds.

"All other birds must be euthanized within 72 hours of capture," Oliva said.

That condition is in direct opposition to Oliva's original mission for the business he started more than a year ago. He envisioned a place where pigeons, which many consider vermin, could live ON THE WEB

out their lives in peace instead of being killed or simply released to create more problems for homeowners and busi-

"I had to make some choices," Oliva said. "We're still absolutely committed to providing sanctuary to birds. It's just not going to happen right now at that

The business wasn't licensed accurately, didn't comply with neighborhood zoning and posed a threat to public health, city officials said.

Officials also weren't crazy about Oliva's chosen uniform, which included a metallic, star-shaped pin that resembled a law enforcement badge.

"We didn't want it to look like he had authority from us to run around the city looking like a police officer," Bedwell said. "We drew a line in the sand."

Oliva has agreed to redesign the

Meanwhile, he's working to extend his 15 minutes of fame, shopping around a reality show called "Pigeon Police: Las

Oliva posted a five-minute "network teaser" of the show on YouTube. It includes staged scenes in which Oliva arrests a man for feeding pigeons and asks an employee to "incarcerate" a pigeon on charges of "public defecation." Oliva

also composed a song, "Here Come the Bird Man," for the clip.

He hopes to use any profits from such a show to fund his ultimate dream: a public pigeon park, somewhere other than North Las Vegas.

Both the city and Oliva are relieved that the bad (bird) blood between them is no more, at least for now.

"He's providing a service that the public wants," Bedwell said. "Nobody came to us and said, 'Get rid of the pigeon guy.' It was more, 'Why are you being mean to the pigeon guy?'

On April 2004, Eddie Felix, a healthy 38-year-old las Vegan, went to the Southern Nevada Endoscopy Center for a routine colonoscopy. Dr. Dipak Desai, referred by Eddie Felix's personal physician, performed the procedure.

Almost four years later, Felix's life, and that of his wife and four kids, was shaken by a two-page letter from the Southern Nevada Health District. Dated February 27, 2008, the letter said he had been "identified in clinic records as a former patient of the clinic who was placed at risk for possible exposure to bloodborne pathogens. As a precaution, and in order to take appropriate steps to protect your health, we recommend you get tested for hepatitis C, hepatitis B, and HIV."

That's because, according to the SNHD in allegations that exploded onto the headlines nearly two years ago, some of Desai's employees had been reusing syringes and medical vials, creating the possibility that disease could spread from patient to patient. The SNHD notification went out to 50,000 people in February 2008.

Today Felix lives in fear, dreading the hematology report. Every few months, the lab technician draws a few syringes of his blood for testing. It takes awhile to get the report. Will it show hepatitis or HIV? Will he live or die? Will his insurance continue to cover this? If only his doctor had not referred him to that center for his colonoscopy ...

"It does get scary," Felix says. "I think about it. You're fighting a threatening disease that you don't know if you'll ever get. It makes me stronger. If it's not there right now, I'm not going to let it get me down. I think I'll deal with it when it does happen if it ever happens. Right now I'm not going to let it stop my life."

Approaching the two-year anniversary of the announcement involving Desai and the Endoscopy Center of Southern Nevada (ECSN), there have been no criminal charges brought, no personal-injury lawsuit taken to verdict or finalized settlement. There are none to

answer the question of accountability or responsibility. No witnesses named to testify or granted immunity. There is a complaint against Desai filed by the Nevada Board of Medical Examiners (BME) on April 25, 2008, which has not been heard due to numerous continuances. (A hearing is set for February 22-25.)

What are the actual acts Desai and others at the ECSN are alleged to have committed? "Certified registered nurse anesthetists (CRNAs) were observed reusing syringes on one patient, reusing propofol vials for multiple patients, reported being directed to do so, and reported routinely doing so," according to the SNHD final report of December 21, 2009.

The Board of Medical Examiners complaint says that Desai "knew, or should have known, of the unsafe practices and policies at ECSN, both as a physician at, and principle [sic] owner of, ECSN, which placed Patient A's health and safety at risk. Respondent failed to use the reasonable care, skill, or knowledge ordinarily used under similar circumstances when he performed a colonoscopy on Patient A, knowing, or being in a position to have known, that the unsafe practices and policies at ECSN could put Patient A's health and safety at risk. ... Respondent violated the trust of Patient A and exploited the physician-patient relationship for financial gain ... knowing, or being in a position that he should have known, of the unsafe practices at the facility that could put the health and safety of Patient A at risk ... "

Shortly after the news broke, the city of Las Vegas suspended the business licenses of Desai's two endoscopy centers.

In all, more than 110 chronic cases of hepatitis C have been allegedly linked to two endoscopy centers in which Desai had a major financial interest; 63,000 may have been exposed to HIV, hepatitis B and C.

The lid is tight on this case. until recently, the Metro officers investigating the case against Desai, and the district attorneys who will prosecute it, were incommunicado. It took 12 days to arrange an interview with someone from Metro. At last, Lt. Dave Logue of the criminal intelligence section said, "We are still pursuing criminal charges. We are coordinating with the district attorney's office. We are in the process of interviewing several witnesses and examining the voluminous pieces of evidence we collected." When asked about the statute of limitations, the maximum length of time after a crime is committed that legal proceedings may be brought, Logue said, "We are well within the time frame for us. This is not a concern for us. The shortest is four years total. We are fairly close, within several months of submitting a final report to the DA's office." He said this case is unique. "No one ever prosecuted this." Logue noted that one detective and one analyst are dedicated to this case full-time.

Herein lies the rub: It is of great concern to those tens of thousands of patients and their family members. If, as Logue said, the statute of limitations is four years (others in the district attorney's office say three years, depending on the charge) then nearly two years have already passed. There is no time for those who have been waiting. Is "still investigating" an adequate answer after 22 months?

Finally, the case was submitted to the district attorney. On December 3, District Attorney David Roger said, "Police detectives ... submitted their file to us within the last couple weeks. It is voluminous. Our prosecutors, Scott Mitchell and Michael Staudaher, will be reviewing the material. I am sure that the public will be informed of the charges sometime after the first of the year. One of the charges suggested is patient neglect. The investigation will be ongoing until a verdict."

Is Desai being charged? Roger would only say: "I don't identify targets until they are charged. They would be people who worked with or at the clinic."

That same day lead prosecutor Scott Mitchell said that the amount of supporting material delivered had to be wheeled in on a dolly. "We scanned over 8,600 pages; they interviewed and got statements from over 100 people." Asked how much the two boxes of material weighed, Mitchell went over and lifted both boxes, saying, "Approximately 25 inches long by one foot deep, together over 100 pounds."

While his main focus is on reading the file, Mitchell said, "It is intimidating enough. I haven't started reviewing it.

"We plan on going to the grand jury, which is a secret proceeding; nobody knows who is being taken to the grand jury. The identity is secret until the grand jury returns an indictment," Mitchell said.

Again time is of the essence and comes to the forefront. If one of the charges is of criminal allegations of medical negligence (NRS 200.495), which is a B felony with a possible sentence of one to six years prison time, the statute of limitations is three years and started running when the first individual was confirmed with hepatitis C, on a case-by-case basis. Other possible charges remain confidential at this time.

According to Mitchell, "The case has been moved from home plate to first base." However, Mitchell will be trying another case before Desai's and will be tied up for several weeks, if not longer. With thousands of pages to read, it may take months before he and Staudaher are able to prepare this case for trial. And since this is a case of "first impression" (a legal issue that has never been decided in that count's jurisdiction), in Las Vegas, who knows how long it will take them to cross home plate?

It's hardly surprising that Las Vegas hasn't had a case like this before. Indeed, the case may be unprecedented anywhere.

Dr. Jonathan Fielding, director of the Los Angeles County Department of Public Health, said through a spokesperson that "nothing like this has ever happened in Los Angeles County," the nation's most populous county, with 10,347,437 people.

New York City, with its approximately 8.3 million? Dr. Sharon Balter, a medical epidemiologist for the NYC Health Department's Bureau of Communicable Diseases, said, "Haven't had one of this magnitude."

Chicago's Cook County, population 5,278,738? "There has never been a large outbreak of any bloodborne pathogen (HIV, hepatitis B, C) from reuse of syringes in Chicago," said Tim Hadac, director of public information for the Chicago Department of Public Health.

Running parallel to the criminal allegations being investigated are the Board of Medical Examiners' charges, filed 21 months ago. Douglas C. Cooper, interim executive director, said, "As has been stated in recent news accounts in Clark County, the criminal case against the Endoscopy Center has met many obstacles. There seems to be a lack of appreciation that the Board of Medical Examiners has met many of the same obstacles, and more. Administrative hearings are currently scheduled for Dr. Desai, in February, 2010; however, we cannot predict how the ongoing issues in the civil and/or criminal matters may affect the board's hearing dates."

Concurrent with these obstacles was the two-year wait for the SNHD's final report. This report—all 266 pages—released December 21, 2009, cataloged and clarified with graphics, detailed cases, clinic practices, procedures and staff, a conglomerate of issues and inferences alluding to whom or what may or may not have caused the hepatitis C outbreak in those 114 or more patients who had colonoscopies at the Southern Nevada centers.

So here's the situation, nearly two years after the allegations came to light: The SNHD released its final report, there is a complaint filed by the BME, the police sent its findings to the district attorney, two prosecutors will be reviewing it and it is early 2010.

Eddie Felix still waits for his blood reports, still hopes and worries if and when he might have an all-clear from his doctor and still wonders if anything will done in time to those involved in what he calls "the biggest greed and arrogant scam" he or anyone else has ever encountered.

"For the pennies they saved, from what I hear, they were just stupid, it was just nonsense.

"What worried me is that you can spread it and get other people sick. And now my wife, Maryann, and she wasn't even involved in it, she ... has to go in for testing, too. Now it's just waiting to see who does or who doesn't get sick from this."

New store is in same location as clinic and advocacy offices

Receiving quality care for HIV/AIDS can mean the difference between survival and death.

That's why the Jan. 14 opening of a new location of The Apothecary Shops, a retail pharmacy chain that caters to Southern Nevada's HIV/AIDS community, will have such a great impact upon the Las Vegas community, according to Fabian Mera, pharmacy sales specialist for the chain.

The 701 Shadow Lane location is the sec-

The 701 Shadow Lane location is the second Las Vegas site for the Arizona-based chain, but the new store's location has special significance, according to Mera.

"Because we are now in the same location as the Southern Nevada Health District's HIV/AIDS clinic, along with the AID for AIDS of Nevada offices, this signifies the establishment of what we believe will be a comprehensive level of services for people with HIV/AIDS," he said.

Mera said the pharmacy specializes in care for this specific disease and staffers are trained to deal with situations and questions clients may be facing with medication or drug interactions.

"Another common problem is that other pharmacies don't have these medications in stock, so the client has to wait days to have prescriptions filled. That will never happen at our stores," he said.

The staff also is available 24 hours a day for consultations, Mera said.

According to Mera, a strict adherence to medication regimens, a controlled diet and following doctors' orders can lead to people living longer. "It is very typical for people with this

"It is very typical for people with this disease to live up to 20 years, depending upon the person and the prescribed treatment," he said "But adherence is the kev."

Mera said there are more than 6,000 people in Las Vegas living with the virus.

The Apothecary Shops offer 10 specialty practices, including infectious disease and pain management, but it is in partnership with agencies such as AFAN, according to Mera, that it provides the best outcome for patients.

"Our goal is for patients to understand that with strict adherence to their drug regimens and by seeking out the needed support, their lives will be extended," he said. "A lack of adherence can, in these instances, result in death."

AFAN Executive Director Jennifer Morss said in a press release that because many of the agency's clients face transportation problems, the convenient location of The Apothecary Shops creates a less stressful situation when they are seeking treatment

"Having these services in the samebuilding can make a difference in a situation that is already fairly stressful," she

Drug has a role in hepatitis cases

Sedative manufacturer might share liability

Attorneys who represent former patients of the shuttered Endoscopy Center of Southern Nevada say that a sworn deposition from a drug company executive will help them prove that his company, which makes the sedative propofol used at the clinic, was partly responsible for the valley's hepatitis Coutbreak.

If proved in court, the drug's role could expose its manufacturer to damages in connection with the outbreak, which unnerved the region when it was announced in February

2008.

In his deposition, Craig Lea, a marketing vice president of Teva Parenteral Medicines in Irvine, Calif, said that a version of the medication for dogs and cats, known by the brand name Rapinovet, has clearer instructions than the milky white propofol used in humans.

white propofol used in humans.
One major difference, he said:
the Rapinovet label states that the
entire contents of the vial should be
drawn into sterile syringes, whereas
the propofol label is not as specific.

That distinction may go to the issue of how the clinic's staff used single-use vials for more than one patient, leading to the infection of others

Lea's deposition was taken in May but hadn't been available until last week. Portions were deleted to protect certain company secrets The Southern thereda Health
District found that as many as
63,000 patients could have been
exposed to infection through reuse
of propofol vials and syringes.
Plaintiffs' attorneys, who will begin
trying Endoscopy Center cases in
April, plan to argue that Teva failed
to properly instruct medical professionals on propofol's use, contributing to the spread of potentially
deadly blood-borne pathogens.
Las Vegas attorney Will Kemp

Las Vegas attorney Will Kemp and fellow plaintiffs' attorney Robert Cottle of Las Vegas said the clinic used 20-milliliter and 50-milliliter vials of propotol, with the larger vials more apt to be reused. With the average adult endoscopy requiing only 10 milliliters — give or take a few milliliters depending on

the size of the patient - they said clinic personnel were encouraged to reuse the 50-milliliter vials for multiple patients to avoid having to discard unused

propofol.
"Hospitals account for all the proposol that they use," Cottle said. "In this case, no one was counting the milliliters that were used. No one was counting clinic wanted to waste any propofol."

It was precisely to avoid the

possible reuse of large vials that Teva at one time made a singleuse, 10-milliliter vial intended for procedures such as endoscopies.

Lea confirmed as much when he said 50-milliliter vials are intended to be used only by one patient for medical procedures that can last many hours, as opposed to endoscopies, which can take less than a half-hour.

"I think a smaller vial size is more ... probably more appro-priate for that, for a shorter duration case," Lea said. A short

time later, he said that the vials are labeled for single-dose use because "you're trying to minimize the amount of product you're throwing away." He also answered affirmatively when Kemp asked whether the 10milliliter vials would reduce the temptation and opportunity for dosing multiple patients from a single propofol container.

Kemp also read into the record a written statement

from Lea indicating that the 10milliliter vials would "enhance

patient safety."

Lea, though, said Teva discontinued the 10-milliliter vials, making the 20-milliliter propofol vials the smallest manufactured by that company and available for endoscopies. Kemp and Cottle are left to question

and cottle are left to question why the clinics even needed or were sold 50-milliliter vials.

"It's a shared responsibility," Kemp said of the hepatitis outbreak. "If Teva hadn't shared the 50-milliliter vials with the Endoscopy Center, the tempta-

tion wouldn't have reuse the vials."

Teva is part of a massive company, Israeli-based Teva Phar-maceutical Industries, with deep pockets. Teva Pharmaceutical, one of the world's largest manufacturers of generic drugs, trades on Nasdaq and has a mar-ket value exceeding \$50 billion.

LVCVA seeks dismissal of lawsuit to stop smoking at tobacco shows

The Las Vegas Convention and Visitors Authority is asking a Carson City District Court to dismiss a lawsuit aimed at preventing smoking at tobacco shows, claiming the society does not have standing to sue.

The American Cancer Society sued in early December claiming a law enacted during the 2009 state legislative session violates the Nevada Constitution's one subject requirement. The law was tacked onto an anti-stalking measure.

The complaint seeks to revise the law so it addresses only stalking.

The lawsuit named the convention authority, Nevada Attorney General

Catherine Cortez Masto and public health officials for pushing for revisions to the Nevada Clean Indoor Air Act, which prevents smoking in public areas such as restaurants, malls, grocery stores and government buildings.

A date has not been set for a hearing.

The convention authority on Monday

The convention authority on Monday filed a motion saying the Cancer Society lacks standing to bring a lawsuit because the society has not been injured by the law's enactment. It also argues that opposition to smoking is a political and policy agenda, an agenda the society lost.

The convention authority called the law a "common-sense approach" to keep tobacco trade shows coming to Las Ve-

"It is difficult to sell tobacco products

to potential buyers if they are prohibited from sampling products they are being urged to purchase," the convention authority's motion said. "Thus, our elected representatives took the common-sense approach to allow smoking within the narrow confines of a tobacco trade show."

The law affects two annual trade shows, according to the authority.

A tobacco convention was last held in Las Vegas in 2008, but exhibitors and attendees were not allowed to sample tobacco products.

The Tobacco Plus Expo and the Retail Tobacco Dealers of America conventions held drew a combined 10,000 attendees adding \$15.7 million in economic impact to the community.

Tom McCoy, director of government

affairs for the Nevada chapter of the American Cancer Society, did not return inquiries for comment Tuesday afternoon.

The Cancer Society's lawsuit, filed Dec. 9, on the eve of the measure's enactment, said a similar stand-alone bill did not make it out of committee early last session

Dec. 8 marked the three-year anniversary of the Nevada Clean Indoor Air Act. It was passed by voters as an initiative and could not be amended for three

The state attorney general's office did not return a call for comment.

Some hepatitis C lawsuits settled

Desai lawyer objects to deal with 18 ex-patients

A district judge Monday approved a settlement of 18 medical malpractice lawsuits stemming from the Las Vegas hepatitis Coutbreak.

The settlement with 18 former patients of the clinics blamed for the outbreak was made by Nevada Mutual Insurance Co. on behalf of doctors and nurse anesthetists who handled their treatment.

Although the cases are a fraction of the roughly 250 filed against the Endoscopy Center of Southern Nevada, its sister clinics and medical workers, Nevada Mutual Insurance's lawyer said this settlement could lead to many more. "This starts the ball rolling,"

"This starts the ball rolling," Nathan Arrington said.

The settlement amount was confidential. Nevada law limits pain-and-suffering damages in medical malpractice cases to \$350,000.

Lawyer Gerald Gillock, who represents all 18 plaintiffs, said the settlement was the result of four months of negotiations and nearly two years of legal wrangling with lawyers for the clinics, doctors and others.

"It's been a long road to get to this juncture," Gillock said.

The settlement saves thou-

sands of dollars in future legal costs and more than a year in court time by avoiding the medical malpractice trials, he said.

The settlement dismisses all medical workers from the lawsuits, including Dr. Dipak Desai, who was the doctor in seven of the 18 cases. The 18 lawsuits will go forward with product liability claims against the drug makers who produced propofol, the anesthetic used at the clinics.

Gillock's group included four of the nine genetically linked hepatitis C cases, including one case set for trial in October.

Desai's lawyer, Kurt Melchior

of San Francisco, objected to the settlement, saying his client never approved of it.

None of the other doctors or nurse anesthetists objected.

Melchior called the settlement an effort to exhaust the malpractice insurance coverage limits, which would leave the thousands of remaining plaintiffs with a smaller pot to collect from.

"They just cannot pay out their policy limits and run," Melchior said of Nevada Mutual Insurance.

The settlement was also opposed by Brian Shapiro, the bankruptcy trustee for the Endoscopy Center and its sister clinics.

His goal is to reach a settlement that will satisfy all of the former patients who have sued the clinics, he said. Any settlements on behalf of a smaller group reduces the amount of money left for the others, he said.

After hearing all the arguments, District Judge Allan Earl approved the settlement, saying it was reached in good faith.

But before any of the patients get paid, U.S. Bankruptcy Judge Mike Nakagawa must rule on whether the medical workers' malpractice payouts belong to the clinics' bankruptcy estate.

If he rules they do, the plaintiffs must ask him to approve the claim reached under the settlement. But if he rules they don't, the settlement would be paid, Gillock said.

Prosecutors to involve grand jury in hepatitis C outbreak investigation

County prosecutors plan to take the hepatitis outbreak case before a grand jury in the "near future" to consider potential charges, District Attorney David Roger said Wednesday.

Roger wouldn't identify possible targets of the grand jury, but Dr. Dipak Desai, who ran the clinics where as many as 115 people contracted hepatitis C because of unsafe injection practices, had been at the center of the Las Vegas police investigation.

Police also suggested charges for at least four other medical workers from the clinics.

Prosecutors had not finalized the charges they will seek, but Roger said they could include patient neglect and insurance fraud. Also, prosecutors had yet to send official notices to suspects that they will be targets of the grand jury.

Roger said he chose a grand jury to accelerate the process of having a large number of witnesses testify. If his office were to go a different route, the time needed to question witnesses and allow cross examination by defense lawyers at a preliminary hearing in Las Vegas Justice Court would make scheduling difficult, he said.

State and federal investigations were ongoing into possible insurance billing fraud at the clinics.

Desai's lawyer, Richard Wright, was out of town Wednesday and unavailable for comment, his office said.

Desai came under scrutiny in February 2008 after the Southern Nevada Health District linked several cases of hepatitis C to the Endoscopy Center of Southern Nevada, 700 Shadow Lane, where he was majority owner.

Officials notified 40,000 former clinic patients about possible exposure to blood-borne diseases because of unsafe injection practices. More notifications followed to patients of a sister clinic,

Desert Shadow Endoscopy Center.

Investigators blamed the outbreak on nurse anesthetists reusing single-dose medicine vials among patients.

Clinic staff told health investigators they were ordered by administrators, principally Desai, to reuse supplies and medications to save money, according to a Las Vegas letter suspending the Shadow Lane clinic's business license.

Health investigators since have linked a total of nine hepatitis C cases to Desai's clinics and said another 106 cases were

"possibly related."

The police investigation ended late last year. Hundreds of former patients have sued Desai, his clinics and the manufacturers of the anesthetic, propofol, that was used during their colonoscopies.

Lawyer Will Kemp, who will try the first civil case by a former clinic patient in April, said the criminal case shouldn't interfere with his trial because Desai is not a defendant in the case.

Desai is a defendant in most of the other cases. The timing of those trials should also avoid interference from any criminal proceedings, but Kemp predicted Desai's legal team would put up a fight every step of the way.

Artisan gets new life Siegel Group vows improvements after purchasing hotel

Local hospitality Siegel Group acquired the Artisan Hotel on Friday, adding the troubled property to the company's growing portfolio of local boutique hotels.

In addition to the 64-room property on Sahara Avenue, Siegel Group owns the 62-room Resort on Mount Charleston and

the 150-room St. Tropez on Harmon Avenue.

Siegel Group's first order of business for the Artisan is to restore the property's reputaremaining employees, Stephen Siegel said. He said the previous owner's cost-cutting measures and bankruptcy filing caused significant damage to the property's reputation. Additionally, the property was hit with numerous health-code violations late last year.

Although only 12 employees were on the payroll when Siegel Group foreclosed on the property Friday, the property is open and all rooms are available, said Michael Crandall, Siegel Group director of business affairs.

The restaurant will reopen by

Feb. 1, he added.

Siegel said he plans to improve the nongaming hotel's customer service and correct any longstanding operational issues.

The Artisan, known for its framed reproductions of famous art work throughout the property and the large fountain in the lobby, will retain the "same theme, same feel, same name."

Siegel added: "We're just modernizing and bringing it up to our standards."

The Siegel Group acquired the property's bank note for \$1.4 million from the Artisan's lender, the Citizens Banks of Oregon in Missouri.

The hotel filed for Chapter 11 bankruptcy in December 2008, listing more than \$10 million in assets against Citizen Bank's \$1.8 million bank note. The bank filed a secured claim that month for an additional \$6 million.

Crandall said the company started to take over the property in late November after the bank decided it did not want to continue talks with the former owner, Doug Da Silva, to restructure his debts. Da Silva also owns a second Artisan Hotel in El Paso, Texas, which is also in bankruptcy.

Da Silva bought the 1.35 acre property, which was a Travelodge, in late 2001. He added hundreds of reproductions of artwork by classic artists such as Paul Cézanne, Leonardo da Vinci, Vincent Van Gogh to Edvard Munch's "The Scream" throughout the hotel.

The property's served as the backdrop for many television shows, including "Criss Angel Mindfreak," Cinemax's "Sin City Diaries" and a photo shoot for the Las Vegas-based band Panic at the Disco.

Siegel said his company will launch an extensive advertising campaign to bring back customers who frequented the Artisan before its sharp decline last year.

The Southern Nevada Health District temporarily closed the restaurant in October after the agency found numerous problems, including spoiled food, dirty food surfaces, a broken dishwasher and mouse droppings on the floor in food storage.

The agency also found insects in the liquor, mold in the ice machine, and dirty linens in rooms.

Crandall said the property has been issued temporary licenses by the health district. Final inspections are scheduled for Friday.

"We have an unbelievable relationship with the agency," Crandall said. "They know when we come in we don't mess around." Crews have been working to prepare the kitchen for reopening within the next two weeks, and Crandall said the remaining liquor was tossed out and replaced.

Many of the Artisan's vendors had stopped delivering products and services to the hotel for lack of payment by the old owner.

But Crandall said Siegel Group's good relationship with vendors — the company also owns the refurbished Gold Spike downtown and Siegel Suites flexible-stay apartment complexes — have helped the company move quickly to address the Artisan's problems.

Beyond restocking the bar, Siegel has already added televisions to the bar, upgraded the property's sound system, replaced the boiler and addressed extensive cleaning and landscaping needs.

Immediate plans include reopening the restaurant by Feb. 1, hiring nearly 60 additional staff, including a general manager, chef, bartenders and cocktail servers.

The Siegel Group plans to spend nearly \$400,000 on the property to add a secured valet parking area, replace some air conditioning units, add a smoke extraction system and purchase new bedding.

Siegel's plans include renovating the pool furniture, marketing an indoor chapel and outdoor area for weddings, building a second bar and opening a hair and tanning salon.

"We're planning with some different concepts," Siegel said. "Gaming, nongaming and some retail components that will drive more traffic here."

Siegel said he has not decided if he will bring limited gaming to the property's bar. Nonrestricted gaming was reinstated at the Resort on Mount Charleston with 10 slot machines in September, and will be available when the renovated St. Tropez reopens in April.

"We can bring games in here, but we're teetering back-and-forth with it," Siegel said. "There's a big following here that doesn't want video games here. We're talking maybe three or four on the backside of the bar."

Siegel said the hotel's room rate will likely fluctuate between \$79 and \$129 per night.

"The property's location to the Strip is unbelievable," Crandall said. "There's a lot of people out there in this country or around the world who love coming to Vegas but aren't necessarily coming to Vegas for the gambling. So this will be a place for them to stay and have an unbelievable experience, and still go to the Strip and enjoy it."

Ample supplies available at the health district, communitywide

LAS VEGAS – The Southern Nevada Health District reminds parents that 2009 H1N1 vaccine recommendations include a second dose for children between the ages of six months and nine years old. The health district offers the 2009 H1N1 vaccine for free at its immunization clinics Monday through Friday from 8 a.m. – 4:30 p.m. For information, contact the immunization clinic, (702) 759-0850 or visit www.snhd.info.

Children between the ages of six months old and age nine should receive the second 2009 H1N1 dose four weeks after the first dose or at least 21-28 days later. Parents should bring their children's H1N1 vaccine record with them when they are to receive the second dose.

The second dose is recommended for children so they develop adequate protection against the 2009 H1N1 influenza strain. Since its identification in April, the 2009 H1N1 influenza virus has become the dominant flu strain this season and it is likely to remain the dominant one for the next several flu seasons. By getting vaccinated now, people can be protected against the strain when it returns in the fall.

Individuals who fall into the originally identified priority groups should receive an H1N1 immunization as they are more likely to develop serious illness or experience complications. H1N1 infection rates were highest among people under the age of 25, including children. Clark County reported two pediatric H1N1-related deaths in 2009.

To date, the Southern Nevada Health District has administered more than 110,000 doses of 2009 H1N1 vaccine. It has received 157,100 doses and an additional 369,000 doses have been delivered to private providers throughout Clark County.

"Brief Intervention" resources available to health care providers Lawrence Sands, DO, MPH, Chief Health Officer

In 2007 the Southern Nevada Health District introduced health care providers to its "Brief Tobacco Use Interventions" program. The program is designed to provide information and resources to health care providers in support of efforts to deliver brief smoking cessation counseling during office visits.

This approach was designed based on clinical trials that demonstrated brief counseling sessions delivered by physicians, dentists and other clinicians increases smoking cessation rates among their adult patients. Many current smokers will be renewing their attempts to quit smoking as part of a New Year's Resolution and the health district wants to ensure the health care community has access to all available resources.

Brief interventions were developed by the Agency for Healthcare Research and Quality (AHRQ) and work by health care providers routinely and consistently delivering a brief 3-step intervention consisting of "the 3 A's:"

- Ask about tobacco use at every visit;
- Advise all tobacco users to stop; and
- Assist the patient by offering medications to aid in quitting and/or referrals to community programs such as the Nevada Tobacco Users Helpline at 1-800 QUIT NOW.

It is recommended that the intervention be repeated at every visit with a patient and can easily be integrated into the current interaction between provider and patient. Brief tobacco use interventions work for a number of reasons including:

- Seventy percent of all smokers see a clinician each year.
- Seventy percent of smokers report wanting to quit and are just seeking the motivation to actually act.
- Studies show that smokers are four times more likely to quit smoking given successful brief interventions and professional assistance than if they attempted to quit on their own
- Each intervention is at most three minutes long. This short time frame is something that already time-strapped physicians and nurses can commit to without abandoning other important services.

Another key component of the program is the partnership with the Nevada Tobacco User's Helpline. The Helpline is the only statewide telephone-based resource and is available for use as a physician referral and free cessation service for patients that do not have access to free cessation services through their health plan. The Helpline provides confidential, telephone-based counseling for tobacco using clients. All counselors are degreed professionals and credentialed alcohol and drug counselors. The Helpline offers different programs and its most intensive, the Level 3 program, has quit rates of 30 percent after 12 months, which is far higher than the national average quit rate of 5 percent.

The success of the interventions is also reflected through the success of the Helpline. The first year after the program was introduced the number of calls to the Helpline quadrupled and more than 20,000 quit cards were distributed through outreach activities conducted with both health district nurses and community physicians. Additionally, the Helpline staff has reported that clients who called as a result of the brief intervention program demonstrated an increased readiness to quit when compared to other clients. Staff members of the Helpline have indicated they believe this is a direct result of the credibility of a health care provider delivering the information to patients. It is also important to note that public health nurses at the health district have been trained to use the intervention program and the majority of those surveyed found the program easy to integrate into client interactions.

In addition to the resources of the Helpline, the program also offers brief intervention materials for health care providers including posters, brochures, rack cards and quit cards. Materials are available in English and Spanish. These materials are available free of charge for health care providers and their patients. Dirty Dining in Las Vegas



Las Vegas, NV (KTNV) - If you haven't finished eating yet, you might want to put down the fork before reading this next story.

Contact 13 Chief Investigator Darcy Spears has been digging in to health inspection reports and she's got important information that you'll want to have before you dig in to your next restaurant meal.


She gives us all something to chew on as she takes us on a tour of the restaurants that got the worst health inspections of the past year.



"We get to see some things that just make us scratch our head and shake it and it's dumbfounding," said Environmental Health Supervisor Greg Wears with the Southern Nevada Health District.

We begin our dirty dining tour at Los Compadres on East Charleston. They got 77 demerits.

Keep in mind any restaurant that gets more than 40 demerits on a health inspection is immediately closed.



Los Compadres was written up for things like moldy tomatoes; expired milk; old, dried food debris on drawers and can openers, and food out of the safe temperature range.

"It's 40 degrees or below for cold food. For hot holding it's 140 degrees or above and anything in between is called the danger zone," Wears explained.

Another violation the health inspector found was uncovered food, which

can easily be contaminated.

"We're going to find everything covered in there, right?" Darcy Spears asked Los Compadres Owner Nuvia Incunca as they entered the restaurant's walk-in refrigerator.

"They should be," Incunca answered.

But, the menudo wasn't and that's a health violation.

"Should there be a cover on that?" Spears asked.

"Yeah," Incunca said, "there should be."

At least there wasn't any food in the mechanical room this time.

The health inspector found pork stored in the mechanical room in an open, dirty, cardboard box.

Ever wonder where that ice in your drink comes from? Los Compadres was storing ice in a garbage can.

"What should we tell people?" Spears asked.

"We trying to do best that we can to resolve all these kind of problems and so we invite everybody and say if we are wrong, we are open and say maybe we are wrong, we have to do something better," Incunca responded.

Our next stop is Kimchi restaurant on the Strip with 71 demerits.

The inspector found food debris, grease, dirt and dust throughout the facility on equipment surfaces, floors, walls, even ceilings.

"Dirt doesn't build up in one day. It takes time," Wears explained.

Would you want kitchen utensils to come out of greasy water?

Well, they did. We also saw a photo of rotten lemons. One is so moldy you can't even tell what it is. But one thing really takes the cake.

"I don't know what that person was thinking," Wears said.

He's referring to kitchen tongs an inspector found in the bathroom of all places, hanging on a plumbing pipe right next to an open toilet tank.

"Under a sink is beyond me," said Wears.

Of course, if you're going to store your tongs in the bathroom, why not place your fly swatter with the clean pots?

Kimchi was also written up for chemicals and medicine stored with food; black and brown slime accumulation inside the ice machine; a paint brush being used as a food utensil; and no tags on the shellfish, which the Health District says is very important because shellfish carry Hepatitis and officials have to be able to trace it to its origin if someone gets sick.

When we went to Kimchi restaurant for an explanation, Scott, the manager, tells us, "Actually, I cannot give you the answer and my owner doesn't want to do pictures or anything."

"Ok, so, officially no comment from you guys?" Spears asked.

"Yes," Scott answered.

A little further east, Kabob 'n' Curry on East Desert Inn was temporarily closed in September after receiving 66 demerits.

The inspector found ants in the condiments; a swollen can of evaporated milk still in use; chicken and beef stew that had to be tossed because it was too dangerous to serve; and ask yourself if you'd want to eat anything that was cooked on this stove.

"We want to see if we can talk to someone about what happened here and whether you guys have cleaned up your act," Spears said to a woman who peered out through the restaurant's chained front door.

The woman tells us to come back because she says the owner's not there. But we found she and her husband are the owners.

When we returned, neither of them were there, but employees called her on the restaurant's phone.

"When I gave you my card yesterday you told me that I could come back and talk to the owner, but apparently the owner is you," Spears said.

The Health District confirmed that. They even showed us a picture with the husband and wife sitting with the inspector on the day they were shut down.

She then tries another tactic: accusing us of trying to hurt her business.

"No one's trying to ruin a business," Spears assured her. "It's about protecting public health and making sure that the public is informed about the places that they go to eat."

The last stop on our "worst of" list is Esmeralda's Cafe on E. Charleston with 68 demerits.

Their report documents things like expired milk...

"I had bought the milk the day before right next door, so, we didn't look at the date," explained Esmeralda's owner Daisy Vega.

Food in the splash zone of dirty dishes.

"That was negligence," Daisy admitted.

Pork and cheese at temperatures that promote bacterial growth.

"Can anybody die from that?" Vega asked. "Can anybody die from any of these demerits that I have written down?"

"I don't think what they're looking for is whether someone's going to die in your restaurant, Spears responded. "It's more what's a good standard of health and cleanliness and what presents a potential hazard."

Vega invites us to see how they've improved after taking a special class put on just for their employees by the Health District.

"Now we do things the right way," she said.

Maybe not always the right way. When we toured the kitchen, we find several things exposed to potential contamination.

But from everything else we see, it looks like Esmeralda's is a good example of how to learn from your mistakes.

Rounding out the bottom five list was Asia Buffet on the Strip. They got 59 demerits and subsequently closed their doors.

We should note that every restaurant in our story was re-inspected and upgraded to an A. You now know about the worst, so what about the best?

Las Vegas Convention Panel Wants Lawsuit Thrown Out


LAS VEGAS -- The Las Vegas Convention and Visitors Authority wants a judge to throw out an American Cancer Society lawsuit aimed at stopping smoking at tobacco shows.

In a court filing Monday, lawyers for the CVA say state lawmakers properly adopted a "common-sense" law allowing smoking at some trade shows.

The convention authority asks Carson City District Court Judge James E. Wilson Jr. to rule that the American Cancer Society Cancer Action Network in Reno has no standing to sue. The Cancer Society lawsuit was filed Dec. 9. It seeks to void a state measure relaxing smoking restrictions at conventions.

It says the measure was improperly attached to a statute making stalking and text-messaging threats a crime -- in violation of a state constitutional requirement that laws deal with a single subject.

Several Endoscopy Patients Receive Settlement

A judge has ruled 18 people who contracted hepatitis C from the Endoscopy Center of Southern Nevada can receive a settlement in their cases against Dr. Dipak Desai.

Judge Allan Earl said each of those 18 patients will each receive an undisclosed amount of money for their case. The money will be paid by the Nevada Mutual Insurance Company.

Attorney's for the 18 patients said the settlement will help begin the healing process for a number of those infected with the diseases,

while also keeping the cases from bogging down the court system.

Details of the settlement between those 18 patients and the insurance company have been made private.

Attorneys for Dr. Desai disagreed with the motion saying Desai was never made aware of any good faith settlements between the insurance company and the patients and that the ruling will open up the flood gates for a number of other people who claimed to have contracted hepatitis C at the Endoscopy Center.

Complicating matters even more is the fact that Dr. Desai has filed for bankruptcy.

Attorney's handling that angle argued that without an official ruling from a bankruptcy judge, the settlement should have been placed on hold.
